**ITEM 1: Frequently Asked Questions**

**1-Q:** Page H-2 states that “performance surveys (included in package) must be completed and accompany bid responses in separately sealed envelopes.” Could you please provide the page number or location where we can find the survey forms?

**1-A:** *The Past Performance Survey is Located is to be completed by your References that you will list on Page H-2.*

**2-Q:** Can you please confirm that the MBE requirement for this RFP is 10%, as stated on page J-15?

**2-A:** *Yes, the MBE Requirement is 10% and 10% for WBE. (For details call: Mss. Chrystal Jordan at 215-684-5856)*

**3-Q:** The Section 3 forms have a different RFP number. Should we still use these in our response?

**3-A:** *Please use Section 3 Forms included in the Solicitation Package P-004384*

**4-Q:** Should our cost proposal include forms H1a and H1e, as indicated, or H1a through H1e? In addition, section H stops at H1c.

**4-A:** *The Cost Proposal need to be completed for all 5 years ( H-1-a through H-1-e)*

**5-Q:** What information should be provided for the General Description/information of services associated with Task 2 on page H-1? Should we include a work plan?

**5-A:** *Please provide the brief General Info/Work Plan (associated with Task 2 “Strategic Planning” Only \_ (Page H-1)*

**6-Q:** Do the five Tasks listed on pages C4 and C5 fall within the 11 services areas listed, or are these considered separate services areas?

**6-A:** *The Five Tasks do fall within the 11 services, but are not limited to them either*

**7-Q:** Can you please confirm that PHA would like one original and five copies of the proposal?

**7-A:** *While submitting the Proposal, please provide with 1 Original and 5 Copies as required.*

**8-Q:** Can you please confirm that we are not required to bid on all components of the SOW?

**8-A:** *Even though this is the Multi Award Bid, all bidders are encouraged to completely fulfill the Scope of Work.*

**9-Q:** Do proposed personnel need to provide personal references, as indicated on page C6?

**9-A:** *Please see Answer 1 shown above*

**9-Q:** As a WBE prime, can Proposer fulfill the entire MPG without bringing in an MBE?

**9-A:** *Yes, WBE prime can fulfill the entire MPG without bringing in an MBE.*

**10-Q:** Should the proposal structure follow the checklist or the outline on page C6?

**10-A:** *It should follow the checklist (page 1 and page2)*


**11-Q:** How many vendors will be selected?
