## NOTICE OF PUBLIC HEARING AND COMMENT PERIOD POLICY DOCUMENTS AND LEASE

The Philadelphia Housing Authority (PHA) is requesting public comments and conducting a public hearing on the following policy and lease documents:

**Public Housing Admissions and Continued Occupancy Policy (ACOP)** – PHA’s admissions and continued occupancy policies for conventional and scattered site public housing are described in the ACOP. A copy of the proposed ACOP and a summary of changes from the current version are available for public review as noted below.

**Lease Agreement** – The Lease Agreement is an agreement entered into between PHA and the Head(s) of Household for each PHA public housing unit. A copy of the proposed Lease Agreement and a summary of changes are available for public review as noted below.

**Community Service Rider** – The Community Service Rider is a rider to the Lease Agreement. PHA proposes to modify the Community Service Rider. A copy of the proposed Community Service Rider is available for public review as noted below.

**Housing Choice Voucher Program Administrative Plan (Administrative Plan)** – PHA’s policies related to administration of the Housing Choice Voucher Program including admissions and continued occupancy policies are described in the Administrative Plan.
