RESOLUTION NO. 11448

PHILADELPHIA HOUSING AUTHORITY BOARD OF COMMISSIONER TO AMEND THE TRUST FOR THE PHILADELPHIA HOUSING AUTHORITY RETIREMENT INCOME TRUST TO CLARIFY ITS TERMS AND TO IMPROVE INTERNAL CONSISTENCY OF THE TRUST AGREEMENT REGARDING BOARD COMPOSITION AND BOARD APPOINTMENT AND REMOVAL.

WHEREAS, the Philadelphia Housing Authority ("PHA") originally adopted the Philadelphia Housing Authority Retirement Income Plan (the "Plan") on November 1, 1952.

WHEREAS, the Plan was reinstated effective November 1, 1984 to clarify its terms and to comply with Federal legislation concerning defined benefit plans.

WHEREAS, the PHA Board of Commissioners created the Philadelphia Housing Authority Retirement Income Trust pursuant to a Trust Agreement by resolution dated February 20, 1991, and such Trust Agreement was signed and effective on February 20, 1991.

WHEREAS, the Authority, including the Board of Commissioner thereof, wishes to amend the Trust Agreement to clarify its terms and to improve internal consistency of the Trust Agreement regarding board composition and board appointment and removal.

NOW THEREFORE BE IT RESOLVED, that the PHA Board of Commissioner hereby approves that the Trust Agreement of the Authority adopted February 20, 1991, shall be amended as follows:

Article I – Creation of Trust, shall be amended to include a new section 1.1C:

"C. Appoints all future Trustees as described in Article V."

Article II – Employer's Duties, shall be deleted in its entirety and replaced with the following:

"ARTICLE II.

EMPLOYER'S DUTIES

The Employer, as the Plan Sponsor, by action of the Board of Commissioners or the Executive Director of the Employer ("Executive Director"), as applicable, shall have the following rights and duties:

- 2.1 To appoint and remove the Trustees and any successor trustees in accordance with Article V;
- 2.2 To deliver any property required by the Plan to be paid to the Trustees;
- 2.3 To act, if so appointed by the Trustees, as Plan Administrator;
- 2.4 To review periodically the performance of any fiduciary or other person to whom any duties or responsibilities have been delegated or allocated under the Plan or pursuant procedures established thereunder, whether or not involving the management and control of the Plan's assets held by the Trust;
- 2.5 To terminate, modify or amend this Trust by written resolution of the Employer's Board of Commissioners or other governing body or person."
- 2.6 To pay the Trustees reasonable compensation for the performance of these duties, to the extent that it does not present a conflict of interest."

Sections 5.4 and 5.5 of Article V, Expenses, Accounts, and Tenure in Office, shall be deleted in their entirety and replaced as described, below, and a new Section 5.6 shall be added:

- "5.4 <u>Resignation or Removal</u>. A Trustee may resign by written notice to the Employer through its Executive Director. A trustee may be removed by the Employer by its Executive Director or by the Board of Commissioners by written notice to the individual Trustee. Such resignation or removal shall be effective on the date specified in the notice."
- "5.5. Appointment of Trustees. The Executive Director of the Employer may appoint up to eleven (11) Trustees. Of these eleven Trustees, one (1) shall be a representative from the Employer's Department of Finance, one (1) shall be a representative from the Employer's Department of Contracts and Procurement, one (1) shall be a representative from the Employer's Office of General Counsel, one (1) shall be a representative from the Employer's Office of Audit and Compliance, and one (1) shall be a representative from the Employer's Department of Communications. Any successor Trustee appointed by the Executive Director shall succeed to all the rights, powers and duties and obligations of a Trustee hereunder. A successor Trustee shall have no liability for the acts or omissions of a co-Trustee or predecessor Trustees that occurred prior to the date of his or her appointment nor shall a successor Trustee be under any duty to examine any prior account of any co-Trustee or predecessor Trustee or to enforce any responsibility in connection therewith."
- "5.6. <u>Administrative Officer</u>. The Executive Director of the Employer may appoint an Administrative Officer. The Administrative Officer shall not be a Trustee and shall not have a vote on the Trustee Board. The Administrative Officer shall assist the Trustees in carrying out the day-to-day functions, including coordinating the maintaining of minutes, correspondence, meeting notices, books and records, and other such functions as designated by the Executive Director of the Employer."

BE IT FURTHER RESOLVED, that all actions taken heretofore with respect to the matters set forth herein by the Executive Director or his authorized designee are hereby ratified and confirmed.

RESOLUTION AUTHORIZING THE ADMINISTRATIVE RECEIVER, OR HIS AUTHORIZED DESIGNEE TO CONCLUDE AND TO EXECUTE A CONTRACT WITH GREENSCAPE LANDSCAPE CONTRACTORS INC., FOR LANDSCAPING SERVICES (SOLICITATION NO. P-004055)

BE IT FURTHER RESOLVED, by and for The Philadelphia Housing Authority, that, based on the recommendation of the Evaluation Committee made pursuant to the preceding paragraph, the Administrative Receiver is hereby authorized to conclude and to execute contracts from among Greenscape Landscape Contractors Inc.; and

BE IT FURTHER RESOLVED, that (1) the recommended contractors comply with all terms required by the solicitation: (2) the contracts are subject to approval by PHA's funding source before any contracts shall exist; (3) no contracts shall exist until signed by the Administrative Receiver, or his designee; and (4) if PHA and the offerors have not mutually agreed on the terms of a contract within forty-five (45) days following the next regularly scheduled Board meeting, then this resolution shall be void and the authority of the Administrative Receiver shall cease.

BE IT FURTHER RESOLVED, by and for The Philadelphia Housing Authority, that, based on the recommendation of the Evaluation Committee, the Administrative Receiver is hereby authorized to conclude and to execute contracts with each of Foundations Inc., Resources for Human Development and Education Works; and

BE IT FURTHER RESOLVED, that (1) the recommended contractors comply with all terms required by the solicitation: (2) the contracts are subject to approval by PHA's funding source before any contracts shall exist; (3) no contracts shall exist until signed by the Administrative Receiver, or his designee; and (4) if PHA and the offerors have not mutually agreed on the terms of a contract within forty-five (45) days following the next regularly scheduled Board meeting, then this resolution shall be void and the authority of the Administrative Receiver shall cease.

RESOLUTION NO. 11451

RESOLUTION AUTHORIZING THE EXECUTION OF A RENEWAL COLLECTIVE BARGAINING AGREEMENT BETWEEN THE PHILADELPHIA HOUSING AUTHORITY AND THE AFSCME DISTRICT COUNCIL 47, LOCAL 2186

WHEREAS, the AFSCME District Council 47, LOCAL 2186 ("Union") are the certified labor relations representative for a bargaining unit of approximately 11 employees; and

WHEREAS, the prior collective bargaining agreement between the Authority and Union expired on March 31, 2009; and

WHEREAS, the Authority and the Union each participated in good faith in extensive negotiations toward reaching a renewal Agreement; and

WHEREAS, the Authority and the Union did amicably reach an Agreement which is attached as the Memorandum of Agreement; and

WHEREAS, the terms of that Memorandum of Agreement are reasonable, practical and supportable from both an operational and budgetary standpoint; and

WHEREAS, Article IX, Section 901 of Pennsylvania Public Employee Relations Act (Act 195) requires that any such bargaining agreement shall be reduced to writing and signed by the parties.

NOW THEREFORE BE IT RESOLVED, that the Philadelphia Housing Authority's Board of Commissioner hereby approves the terms of the Memorandum of Agreement that is attached; and authorizes the Administrative Receiver to execute and implement a renewal Collective Bargaining Agreement consistent with those terms.

RESOLUTION NO. 11452

RESOLUTION AUTHORIZING THE EXECUTION OF A RENEWAL COLLECTIVE BARGAINING AGREEMENT BETWEEN THE PHILADELPHIA HOUSING AUTHORITY AND THE AFSCME DISTRICT COUNCIL 47, LOCAL 2187

WHEREAS, the AFSCME District Council 47, LOCAL 2187 ("Union") are the certified labor relations representative for a bargaining unit of approximately 64 employees; and

WHEREAS, the prior collective bargaining agreement between the Authority and Union expired on March 31, 2009; and

WHEREAS, the Authority and the Union each participated in good faith in extensive negotiations toward reaching a renewal Agreement; and

WHEREAS, the Authority and the Union did amicably reach an Agreement which is attached as the Memorandum of Agreement; and

WHEREAS, the terms of that Memorandum of Agreement are reasonable, practical and supportable from both an operational and budgetary standpoint; and

WHEREAS, Article IX, Section 901 of Pennsylvania Public Employee Relations Act (Act 195) requires that any such bargaining agreement shall be reduced to writing and signed by the parties.

NOW THEREFORE BE IT RESOLVED, that the Philadelphia Housing Authority's Board of Commissioner hereby approves the terms of the Memorandum of Agreement that is attached; and authorizes the Administrative Receiver to execute and implement a renewal Collective Bargaining Agreement consistent with those terms.
